FNS enables users to create, manage, and disseminate Notices to Air Mission (NOTAMs). These NOTAMs provide important information about changes to National Airspace System (NAS) infrastructure and services to pilots, air traffic control (ATC), and other NAS users.

NOTAM originators include Airports, DoD, Technical Operations, Tower Flight Operations, Procedure and Charting, and Airspace. NOTAM consumers include pilots, airlines, ATC, and other NAS stakeholders.
