


The system uses two main types of inspections; Design Assessments which assess the design of an air carriers systems (initially associated with certification) and Performance Assessments (surveillance based) which examine the outcomes that these systems produce.</p> <p>The application is web based and is used by ATOS inspectors to perform certificate management oversight according to the processes of the Design Assessments and Performance Assessments mentioned above. This application is composed of a number of modules.</p>
