Provides a repository of motor vehicle crash data related information and publications in the form of pdf documents that are publicly available via the NHTSA web-site. 2. Provides a way for a submission of a customer's request for motor vehicle crash data related information or publications. These requests involve the collection of (PII) personal information such as, customer name, address, phone number, email and organization. This personal data can only be accessed internally by authorized employees (called agents) who have the ability to login into the CrashStats system using a unique user ID and password. This personal data is placed behind the NHTSA fire wall. All PDF documents are input by an authorized employee who has the ability to login into the system using user ID and password. The requester information is entered by CrashStats agents as well as by the requester using an online form. It also provides analytical documents for use by highway safety professionals on the NHTSA web and as a communication tool by CrashStats agents with motor vehicle crash information requesters.
