Background Information New schedule items; previously unscheduled. The Unified Registration System (URS) is required by the ICC Termination Act of 1995 (ICCTA) and the Safe, Accountable, Flexible, and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). In the ICCTA, Congress enacted 49 U.S.C. 13908, which directed the Secretary of Transportation (Secretary) to issue regulations to replace certain existing registration and information systems with a single, online, Federal system. SAFETEA-LU modified the requirements for a unified registration system contained in the ICCTA. The URS will consolidate the following registration and information systems: (1) the U.S. Department of Transportation (USDOT) identification number system; (2) the 49 U.S.C. chapter 139 commercial registration system; (3) the 49 U.S.C. 13906 financial responsibility information system; and (4) the service of process agent designation system (49 U.S.C. 503 and 13304). The URS will improve the registration process for motor carriers, property brokers, freight forwarders, and other entities required to register with FMCSA, and also increase public accessibility to data about interstate motor carriers, property brokers, and freight forwarders.

URS is the repository of FMCSA's comprehensive record of safety performance and compliance histories of motor carriers, property brokers, freight forwarders, intermodal equipment providers, and cargo tank facilities subject to the Federal Motor Carrier Safety Regulations and the Hazardous Materials Regulations. It serves as a centralized repository of data that is used by various FMCSA offices, other Federal, State, and local agencies, organizations, commercial entities, or the general public.
