Background Information	<p>The VA Prosthetics Center (VAPC) was established in 1956 at the VA Facility in Brooklyn, NY, to organize and publish the research, engineering, production and purchase of prosthetic devices for Veterans. The VAPC carried out a variety of practical projects, primarily to improve upper and lower limb prostheses. It became increasingly involved in the evaluation of devices developed by others. With the advent of improved and more timely treatment of soldiers (helicopters, MASH units) more soldiers were surviving, but with significant loss of limbs, visual function and communicative disorders; there was a need for a more vigorous approach to prosthetics and rehabilitation.</p> <p>A key contribution led by Dr. Eugene Murphy was starting and continuing publications to share information among the prosthetics and sensory aids community. From 1954 to 1972, with VA support, the National Research Council (NRC) published a journal called Artificial Limbs. To cover the broader field of research included in it's Prosthetics and Sensory Aids research program, the VA started its own Bulletin of Prosthetics Research (BPR) in 1964.</p> <p>The BPR presented VA sponsored research. both as progress reports and original articles. It also presented other research in the field. Recognized as a primary source of state-of-the-art information about research in prosthetics and sensory aids; by 1983 the BPR had expanded to include all areas of rehabilitation and changed its title to reflect its broader scope to become the JRRD.</p>

In 1986 an investigation of the VAREC Veterans Affairs Rehabilitation Engineering Center processes revealed a need to relocate them to Baltimore and to locate four other Centers in the 103 S. Gay St. (Appraisers Stores) Building. JRRD was originally published quarterly; however, the emerging cross disciplinary findings in rehabilitation have warranted a further expansion in scope and JRRD has increased to bi-monthly publications with multiple single-topic supplements. It increased in number of submissions, number of issues published annually and the scope of coverage broadened after Vietnam and Desert Storm conflicts. An on-line submission and review process was instituted approximately thirteen years ago.

In 2015 the NRAC for the Office of Research and Development (ORD) was chartered to review the operations of JRRD and they recommended the closing of the JRRD. This was done at the end of fy2016.

The JRRD is a peer reviewed and indexed multidisciplinary publication of the DVA, ORD, and Rehabilitation Research and Development (RRD). The core mission is to distribute the results of technical and clinical research into the rehabilitation from injuries and diseases suffered by Veterans as a result of their service. The JRRD accepts submissions from researchers in and outside the DVA and is distributed internationally through its printed editions and on-line posting in the ORD website.
