ENTRANCE & SEPARATION (E&S) X-RAYS

a. Chest X-rays exposed in conducting the medical examination preliminary to an individual's entry into, or release from extended military service.

b. The Veterans Administration (VA) assumes legal custody of all Army, Navy and Air Force entrance and separation X-rays immediately upon their retirement to the National Personnel Records Center, (NPRC) St. Louis, Missouri.

DISPOSITION:

a. All E&S X-rays, excepted as noted below: Dispose of when 65 years old in accordance with Federal Personal Property Management Regulations and with the concurrence of VA on each disposal action.

b. Army and Army Air Force X-rays, dating prior to 1960, and Air Force X-rays, dating prior to 1964; Dispose of when no longer needed in the reconstruction of military service records, but not prior to the expiration of the 65 year retention period and the restrictions specified in "a" above.
