Background Information A component of the Executive Office of the President, ONDCP was created by the Anti-Drug Abuse Act of 1988. ONDCP advises the President on drug-control issues, coordinates drug-control activities and related funding across the Federal government, and produces the annual National Drug Control Strategy, which outlines Administration efforts to reduce illicit drug use, manufacturing and trafficking, drug-related crime and violence, and drug-related health consequences.

The principal purpose of the Office of National Drug Control Policy (ONDCP) is to establish policies, priorities, and objectives for the Nation's drug control program, with the overall goal of significantly reducing the production, availability, and use of illegal drugs both here at home and abroad.
