Political appointees are any individual appointed by the President or Vice President (whether or not confirmed by the Senate) including Political Schedule A and Schedule C appointments in the excepted service; political appointees as defined by 5 U.S.C. 5312-5316; non-career, limited term and limited emergency SES employees and any political employees serving under a statutory authority specific to the FRA-creating components of EOP.
