Background Information The Office of International Affairs leads and coordinates the FTC's work in international antitrust, consumer protection and privacy, and technical assistance projects. The FTC works with competition and consumer protection agencies around the world to promote enforcement cooperation and convergence toward best practices.

OIA leads the FTC's efforts to negotiate bilateral and multilateral cooperation arrangements and agreements. This includes participation in negotiating relevant chapters of U.S. Free Trade Agreements and working with FTC bureaus and offices and other federal agencies.

OIA actively assists developing countries in their transition to market-based economies and their development of competition and consumer protection agencies by providing advice to such agencies and, in partnership with the Antitrust Division of the Department of Justice, operating a technical assistance program.

The Undertaking Spam, Spyware, And Fraud Enforcement With Enforcers Beyond Borders (U.S. SAFE WEB) Act of 2006 authorizes the FTC to disclose certain privileged or confidential information to foreign law enforcement agencies to support foreign investigations or enforcement actions.
