## 1. TECHNICAL SUGGESTIONS

This series contains technical suggestions submitted by TVA employees for new research or improvement of existing Chemical Development processes. Many are the basis for patents. The Muscle Shoals Technical Library has indexed these records into their computerized information system (CATLIRS). This system provides TVA employees only, access to some brief information about all previous technical suggestions. If a TVA researcher discovers through CATLIRS that an idea they are working on was considered in a previous technical suggestion, they review the detailed record of the previous suggestion. There is only one complete set of these suggestions, and it is located in the National Fertilizer and Environmental Research Center (NERC) official file room. However, it is maintained separate from the correspondence file. The suggestions are filed and indexed by number and by author. The inclusive dates are 1939 and continuing. The approximate volume is 20 cubic feet.

### DISPOSITION
