1. CONSTRUCTION PROJECT REPORTS ON STRUCTURES AT DAMS AND OTHER CONSTRUCTION PROJECTS

These project reports contain information on all structures that were constructed in connection with each TVA dam, including the dormitories and houses that were built for workers at many of the early dam sites. The reports for each project are filed in 11 x 17 binders. Included in each report is a form TVA 406, Structural Detail Sheet; description of each structure; copies of blue prints for each structure; and at least two black and white photographs of each structure. Information is included to show if a structure was removed and the date of removal or if a structure was sold, the date of sale. The inclusive dates are 1933 through the 1940's. The volume is 11.5 cubic feet.
