In the decision process the responsible Federal Agency is required to obtain review and assessment from other Federal Agencies that have expertise relating to specific areas of the projects or agencies whose programs may be affected by the project.</p> <p>The file consists of the draft statement, TVA comments coordinated by the Division of Environmental Planning, and the final statement. The final Environmental Impact Statement, which is received from the issuing agency, includes the response or handling of all comments.
