The Commission previously updated its race/ethnicity and job categories on the FCC Form 395 to conform to the race/ethnicity and job categories used by the Equal Employment Opportunity Commission (EEOC). Requirements for filing personal information on FCC Form 395 is authorized by the Communications Act of 1934, as amended. The Commission requires carriers to file the Form 395 data electronically and is available for inspection in WC Docket No. 16-233 within the Commission's Electronic Comment Filing System (ECFS).</p>
