Cable Price Survey Data and Databases (2000 to Present)

The proposed disposition instructions for the following record series apply to records in all media and format.

~~1. Input/Source Records:~~

~~Annual Cable Price Survey Data — Randomly selected cable operators complete the price survey. The survey is designed to solicit information concerning rates for basic and expanded basic cable programming services and equipment used to receive those services. Users submit the cable price survey electronically. Paper versions of the survey are furnished to respondents who do not have access to a computer. The survey results are published in an annual report on cable industry prices. Supplemental questions may also be included.~~

~~Disposition: Temporary. Destroy/delete annual cable price survey data ten years after data is verified and input into database.~~

2. Master File

File consists of data from survey questionnaire as responded to by cable operators. The data is arranged by survey questionnaire. Arranged alphabetical by cable operator's file identifier code. Additional variables are created based on operator submissions.

Disposition: Temporary. Delete 10 years after end of reporting period.

3. Outputs

a. Annual Cable Price Survey Report

Disposition: Temporary. Destroy 10 years after report is published.

b. Screens of information, printouts, publications, final studies.

~~Disposition: Destroy when updated or no longer needed, whichever is sooner.~~
