


**Certification for Open Video Systems, FCC Form 1275 (or equivalent)**

Open Video Systems (OVS) provides an option for the distribution of video programming other than as a cable system by introducing competition into the entertainment and information markets, pursuant to 47 USC Section 302. Applicants may file for certification to operate an OVS system with the Commission via FCC Form 1275. Such certification requests must go on public notice to provide interested parties an opportunity to comment. These requests do not receive a CSR number. Comment period is five days as the Commission is required to issue an order within 10 days after receipt of an applicant's request. OVS operators must file a notice of intent to establish an OVS which the Commission will release via public notice. The file consists of incoming completed FCC Form 1275, opposition, reply and any related correspondence, notice of intent, FCC decisions, reconsiderations and/or applications for review, if applicable.

1 Requests granted

Disposition Temporary Destroy when certification is revoked or obsolete

2 Requests denied and not appealed

Disposition Temporary Destroy when right to appeal lapses

3 Requests denied and appealed

Disposition Temporary Destroy 30 years after final determination by agency, 6 years after the time at which a requester could file suit or 3 years after final adjudication by the courts, whichever is sooner
