# **Records Schedule - Section 43.82 Circuit Status Reports**

### 1. Circuit Status Reports

Each facilities-based common carrier engaged in providing international telecommunications service between the area comprising the continental United States, Alaska, Hawaii, and off-shore U.S. points and any country or point outside that area must file a circuit status report with the Commission not later than March 31 of each year showing the status of its circuits used to provide international services as of December 31 of the preceding calendar year.

The annual circuit status reports are filed pursuant to 47 C.F.R. Section 43.82. The information contained in the reports include the total number of activated and the total number of idle circuits by the categories of submarine cable, satellite and terrestrial facilities to geographic points outside the United States for the services designated by the Commission. Filers of these reports may request confidentiality.

Disposition: Temporary. Destroy three years after filing.

### 2. Manual for Filing Section 43.82 Circuit Status Report

The Manual contains detailed filing requirements for submissions of the Circuit Status Reports.

Disposition: Temporary. Destroy 3 years after superseded or when no longer needed, whichever is later.

## 3. Circuit Status Data Publication (1996 - )

The Circuit Status Publication contains information on U.S./international facilities-based common carrier circuits that are submitted to the Federal Communications Commission by U.S. common carriers pursuant to section 43.82 of the Commission's rules. The Publication may also contain for comparison purposes, data from previous reports. The services covered by the Publication include International Message Telephone Service (IMTS) (switched voice), International Private Line Service (IPLS) (including voice and data) and Miscellaneous or Other International Services (including data services other than private line service) provided on a common carrier basis. The aggregated data listed in this report reflects all of the submitted information, including information from carriers requesting confidential treatment.

Disposition: Temporary. Destroy when 15 years old or when no longer needed, whichever is later.
