Section 64.903 of the Commission's rules requires that each local exchange carrier with annual operating revenues equal to or above the indexed revenue threshold, as defined in Section 32.9000, shall file with the Commission a cost allocation manual (CAM) that specifies how the carrier will allocate its cost between regulated and nonregulated operations.
