Background Information The records covered by this schedule document the data collected, analyzed and stored in the Integrated Surveillance System or ISS. The current schedules do not meet the needs of the analysts, and in some cases, the retention requirements are difficult to track and implement. The new schedule not only consolidates nine of the previous ISS schedules into one schedule, it also simplifies and expands the overall retention period.

It has been determined that the ISS data should be held for 40 years. The analysts need at least 30 data points to perform reasonable statistical analysis. Because CFTC is the oversight agency for commodities and many of these commodities are crops, for these purposes, 30 data points equates to 30 growing seasons. Each growing season is one year. An additional 10 data points or 10 years is provided for a look back for comparison. This is the basis for the proposed 40-year retention.
