It functions as the agency's primary contact with the news media, and is responsible for preparing and distributing press releases and a variety of publications that provide information on the agency's benefit programs. The Congressional Inquiry section is responsible for responding to all inquiries from congressional offices concerning constituents, benefit claims or applications filed with the agency.

Justification of Proposed Retention(s)

Combined Federal Campaign (CFC) Records - This is a new series that consists of records associated with the management of the RRB's annual CFC initiative.
