Description:

Executive Order 12686 established the President's Commission on Aviation Security and Terrorism to review and evaluate policy options in connection with aviation security, with particular reference to the destruction on December 21, 1988, of Pan American World Airways Flight 103. The commission was extended to May 15, 1990 in Executive Order 12705. The Aviation Security Improvement Act of 1990 signed on November 16, 1990 was based on the recommendation of the commission (report issued May 15, 1990).
