
Federal entities may cease operations when they are established as a temporary entity, are abolished, or functions are transferred to state or local government or private control.

Description:

Congress established the National Commission on Severely Distressed Public Housing through the 1989 National Affordable Housing Act (Public Law 101-235; 103 Stat. 2048) of December 15, 1989. The Commission submitted its final report to Congress and the Department of Housing and Urban Development on August 15, 1992, which terminated the Commission.



The National Commission on Severely Distressed Public Housing (NCSDPH) was established by Congress, pursuant to Public Law 101-235 enacted December 15, 1989, to define and identify severely distressed public housing. The Housing Commission was also established to assess strategies for eliminating severely distressed public housing and to establish a National Action Plan to eliminate distressed public housing by the year 2000.

The NCSDPH is a temporary Commission that is a part of the Federal government.
