National Commission on Migrant Education
Attachment to 116-109

In 1988 Congress created the National Commission on Migrant Education (NCME) and in so doing launched a nationally recognized effort to study issues relating to education programs for migrant children. The Commission is bipartisan and is comprised of four presidential appointees, two U.S. Senators, two Congressmen, and four members of the public appointed by the Congress.

The Commission holds hearings and meetings around the country. Each is designed to hear views of program constituents, educators, administrators, and researchers. In addition, the Commission is reviewing and analyzing all existing documentation on migrant education.

Through the release of two reports the Commission will make recommendations to the President and Congress on how to improve migrant education programs. The first report was released in August 1991 and focused on the function and the effectiveness of the Migrant Student Record Transfer System. The second report is due for completion in the fall of 1992 and will respond to the mandated issues. It is expected that the recommendations contained in these reports will form the basis for legislative proposals in the area of migrant education.
