The Commission on the Review of the National Policy Toward Gambling was authorized by Section 804 of the Organized Crime Control Act of 1970 (84 Stat. 938), approved October 15, 1970, to be activated no earlier than October 15, 1972, and to submit a final report no later than October 15, 1976. The Commission terminated upon submission of final report, October 15, 1976, published as "Gambling in America."
