## Description:

National Commission on Employment and Unemployment Statistics was authorized by Section 13(b)(1) of the Emergency Jobs Programs Extension Act of 1976 (90 Stat. 1484), October 1, 1976, to recommend measures to improve the collection and dissemination of national labor statistics. Activated June 27, 1977, with the Presidential appointment of labor economist and university professor Sol A. Levitan as chairman. First meeting held April 6, 1978. Terminated following submission of final report, September 3, 1979 (Labor Day), published as Counting the Labor Force.
