Description:

President's Commission on the Accident at Three Mile Island was established by EO 12130, April 11, 1979, to issue an investigative report on the March 28, 1979, accident at the Unit 2 nuclear power plant on Three Mile Island, PA, that had resulted in the escape of radiation. Chaired by college president John G. Kemeny. Became inactive upon submission of final report, October 30, 1979, published as Report of the President's Commission on the Accident at Three Mile Island. Officially terminated by EO 12258, December 31, 1980.
