## Description:

The Commission on Population Growth and the American Future was established by an act of March 16, 1970 (84 Stat. 67), to examine the probable course of U.S. population growth to the year 2000; evaluate the impact of such growth upon government activities and upon the environment; and recommend appropriate means to achieve a population level suited to the nation's needs. The commission was chaired by philanthropist John D. Rockefeller III. The commission terminated upon submission of final report, March 27, 1972, published as "Population and the American Future."
