INTERNATIONAL SATELLITE FOR IONOSPHERIC STUDIES (ISIS-2)  
Data Tapes (magnetic)

This series of records consists of experimenter data tapes for the ISIS-2 satellite covering the period from 1971 to 1978. Tapes contain telemetry data with some machine adjustments incorporated. Data is unanalyzed as received from the ISIS-2 retarding potential analyzer. The Principal Investigator, Dr. Eugene Maier, has retired from NASA/GSFC and currently the project is considered complete. Data tapes have potential use for future projects and contain valuable information for current use to researchers. The collection of data tapes consists of approximately 130 boxes of 10" magnetic tapes, and are located at GSFC. *This job does not apply to ISIS-2 records maintained at NSSAC. C95 5/22/96*
