Background Information The Office of Minority and Women Inclusion (OMWI) was established within the U.S. Securities and Exchange Commission (SEC) pursuant to Section 342 of the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010 (the Dodd-Frank Act), and assigned responsibility for all matters relating to diversity in the agency's management, employment, and business activities. This schedule pertains to the records created or received by OMWI as it effectuates the provisions of Section 342 of the Dodd-Frank Act, which require the OMWI Director to develop standards for (a) equal employment opportunity and diversity in the agency's workforce; (b) increased participation of minority-owned and women-owned businesses in the SEC's programs and contracts; (c) assessing the diversity policies and practices of entities regulated by the SEC; and (d) making determinations concerning the good faith efforts of SEC contractors to ensure the inclusion of minorities and women in their workforces.
