Background Information	<p>The Whistleblower Program was created by Congress to provide monetary incentives for individuals who voluntarily provide original information that leads to the success of an SEC enforcement action in which a judgment over \$1 million is obtained. Under the program, eligible whistleblowers are entitled to an award of between 10% and 30% of the monetary sanctions collected in the underlying action, as well as any related actions brought by certain law enforcement or regulatory agencies based on the same whistleblower information. Awards are available only in connection with information submitted to the SEC after the enactment of Dodd-Frank on July 21, 2010. The Office of the Whistleblower ("OWB") was established to administer the SEC's Whistleblower Program.</p> <p>The OWB posts Notices of Covered Action for each SEC action where a final judgment or order, by itself or together with other prior judgments or orders in the same action issued after July 21, 2010, results in monetary sanctions exceeding \$1 million. Once a Notice of Covered Action is posted, individuals have 90 calendar days to apply for an award. OWB reviews the application for award and makes a recommendation to grant or deny a whistleblower award. That recommendation is reviewed by a claims review staff, which issues a preliminary determination. An applicant may request to review the record upon which the claims review staff relied in issuing the preliminary determination. An applicant may also request reconsideration of a denial, or of an award in pursuit of a larger award percentage. Recommendations for awards and all reconsideration requests are sent to the Commission, and the Commission issues a Final Order. A redacted public version of the Final Order is published.</p>
