	<p><u>Institutional Investor Study (IIS), 1969-1971</u></p> <p>This collection of data was initially received from the SEC in June 1971 (Final Master File). Also received were public use files for some of the individual surveys conducted for the IIS. Data from the stack file were extracted by staff of the National Archives and preservation copied. The original 'Final Master' file is now recommended for disposal due to excessive data checks.</p> <p>In January 1980, a comprehensive set of IIS files were received by NARA transferred from storage at the Federal Reserve Board, along with associated documentation. Duplicates of files already included with the 1971 transfer were necessarily included in the 1980 transfer of IIS data files.</p> <p>During FY1992, staff in the Center for Electronic Records reappraised this collection and have recommended the attached datafiles/tapes for disposal due to excessive datachecks and/or inadequate documentation. In addition, duplicates of some files have been recommended for disposal, with one version retained as the record copy and preservation copied.
