	<p>The 669 cubic feet of records included in this Request for Records Disposition authority are primarily engineering construction project files relating to the construction of facilities at AEC and DOD test sites in the Pacific Ocean Area and Nevada. These records were created by and retired into FRC, Los Angeles by Holmes and Narver, INC, the prime contractor to AEC for construction and facilities maintenance.</p> <p>The records, identified in this request by the 77 FRC Accession numbers under which the records were retired, consist of engineering drawings, photographs, test data, geological data, establishment of reference points, and reports of other tests used for reference purposes. The data provided in the records is preliminary or intermediate. There are no final or other test reports included in these files.</p> <p>Upon archival processing of these records, which had been accessioned over the past several years, their archival value was questioned. Additionally it was discovered that the permanent authority under which the records were retired had never been approved and the records transferred were not, in most cases, as they were described in the schedule.</p> <p>Per request of the National Archives - Pacific Southwest Region, Dick MacKay, NIR, conducted a reappraisal of these records during the week of May 6, 1996. He provided a more complete description and added the recommended disposition for each series that is recommended for deaccessioning and disposal.</p>
