	<p><u>Synthesized Interim NUDOCS System (SINS), NRC System 9597</u></p> <p>This records schedule covers an electronic information prototype system that contains electronic versions of NRC programmatic records contained in a data base that the NRC has determined to be of no further value and for which support has been discontinued. The system was not used for recordkeeping purposes and the official records are maintained elsewhere in hard copy. The documents contained in the system are available for reference by NRC staff in other electronic information systems, on 48X Nuclear Documents System (NUDOCS) microfiche, and/or in the official records maintained in paper format.</p> <p>The purpose of the electronic information system was to create a small-scale text/document search prototype system that was available to a representative number of staff through the agency's Local Area Network to obtain knowledge useful in the redesign of the full-text capabilities of the NRC's NUDOCS. The information consists of unauthenticated electronic versions of a</p>		

small collection of selected programmatic documents from calendar year 1993 along with related indexes and programming. NRC requests authorization to destroy or delete the data when determined to be no longer needed for operational purposes.

Electronic information prototype system containing unauthenticated electronic versions of selected NRC programmatic text and documents dated 1993.
