Item 1 RECORDS RELATING TO RACE AND EDUCATION

1a. Press Clipping Collection: The Integration of the University of Mississippi by James Meredith, 1962-1964.

This series consists of local, state, national and international newspaper accounts of the efforts of James Meredith to enroll at the University of Mississippi and the riot that resulted from his enrolling in October 1962.

Disposition: PERMANENT. Transfer to the National Archives immediately.

1b. Hearing Transcripts: Equal Education Opportunity on American Cities, 1967.

This series consists of verbatim transcripts from hearings and workshops sponsored by the USCCR in 1967 to address the lack of educational opportunity, especially for minorities, in urban areas.

Disposition: PERMANENT. Transfer to the National Archives immediately.

1c. Computer Printouts: NORC Survey, 1966.

This series consists of printouts from the 1966 NORC survey about black education. The printouts consist of data sorted in a variety of ways and cross tabulation printouts using an unidentified statistical analysis program. There is no explanatory text, code book, record layout or other documentation to accompany these records.

Disposition: Destroy immediately.

Item 2 RECORDS OF THE OFFICE OF GENERAL COUNSEL, 1960-1967

2a. Records Relating to the Voting Rights Act of 1965.

This series consists of correspondence, drafts of legislation, press clippings and field reports (filed by USCCR monitors) relating to the Voting Rights Act of 1965.

Disposition: PERMANENT. Transfer to the National Archives immediately.

2b. Hearings and Meetings File, 1964-1967.

This series consists of correspondence, transcripts and reports to the General Counsel or other USCCR officials relating to a number of public hearings and meetings

held by the USCCR between 1964 and 1967. These hearings dealt with a number of local civil rights issues such as housing, school and other public desegregation, voting and political participation.

Disposition: PERMANENT. Transfer to the National Archives immediately.

2c. Complaint Case Files, 1960-1964.

This series consists of letters received by the USCCR from individuals regarding the violation of their civil rights between 1960 - 1964. The Commission investigated each complaint and prepared a fact finding report. This report contained the original letter and additional correspondence, copies of legal opinions and recommendations to other agencies.

Disposition: PERMANENT. Transfer to the National Archives immediately.

Item 3 RECORDS OF THE OFFICE OF FEDERAL PROGRAMS RELATING TO TITLE VI OF THE CIVIL RIGHTS ACT OF 1964

3a. Legislative History Files, 1963-1964.

This series consists of drafts, correspondence, memorandums and comments relating to the development of Title VI of the Civil Rights Act of 1964.

Disposition: PERMANENT. Transfer to the National Archives immediately.

3b. Oversight and Review Files, 1964-1967

This series consists of correspondence and internal reports relating to the USCCR's review of state and local public works projects which received Federal assistance. It also contains correspondence and reports (both internal and to the effected agency) examining Federal agency guidelines and procedures. These reviews were conducted to ensure that programs receiving Federal aid and Federal agencies were complying with Title VI of the Civil Rights Act of 1964.

Disposition: PERMANENT. transfer to the National Archives immediately.

3c. Miscellaneous Travel Records

This series consists of travel vouchers, itineraries and correspondence relating to trips taken by USCCR officials.

Disposition: Destroy immediately. (GRS 9, Item 4a)
