Background Information The Peace Corps provides a passport to Volunteers who serve abroad. As per Department of State regulations, they are required to submit original documents (Department of State passport or original birth certificate, etc.) in order for the Peace Corps to facilitate the issuance of a Peace Corps passport through the Department of State. In some instances, the Volunteer goes through the application process, but then does not end up serving. The Peace Corps attempts to return all documents but occasionally, the contact information is not valid and the applicant cannot be reached in order to return the documents. This usually occurs because the Volunteer applies while in school and uses a school email address, physical address, and school phone number - all of which becomes invalid when the student leaves school.
