GENERAL RECORDS

1. JUDICIAL DISTRICT ADMINISTRATIVE FILES, 1899-1939 and 1946-58, 370 cu. ft.

Arranged by court (district courts are arranged alphabetically by state and geographical district and courts of appeal numerically by circuit) and thereunder by subject, with files relating to matters applicable to all districts placed at the head of the series for the period 1899-1939.

Note: the 1899-1939 segment of the series, maintained at one time by the Justice Department, was originally arranged under a duplex numeric filing system that identifies the source and subject of the correspondence.

Consists chiefly of correspondence with judges, clerks of court, referees in bankruptcy and other officials of the Federal courts about such matters as the following: examination of judicial offices; accounts, salaries and fees; authorizations of expenses (travel, printing, etc.); personnel (appointment, leave, and resignation); and statistical reports. The records include examiners' reports that date from as early as the 1920s.

2. GENERAL CORRESPONDENCE FILES, 1950-58, 17 cu. ft.

Divided into two segments, one of which covers Federal agencies and the other of which covers firms and persons outside the Federal government. The agency correspondence is arranged alphabetically by agency and thereunder chronologically. It includes correspondence with members of the two houses of Congress. The non-Federal correspondence is arranged alphabetically by correspondent and thereunder chronologically.

Consists of correspondence with Federal agencies and outside parties over such housekeeping and facilitative matters as bids, billings, collections and financial statements, crediting and disbursement of funds, transmittal of examiners' reports, and FBI background investigations.

Arranged by recipient and thereunder chronologically.

Consists chiefly of memoranda from subordinates to such AOUSC officials as the Director, various Assistant Directors and Deputy Assistant Directors, and Chiefs of Divisions. The records relate to such issues as personnel, expenses, space, examination of judicial offices and other largely facilitative matters.

File markings indicate that earlier segments of these files existed at one time.

Consists of final drafts of letters and memoranda issued by the director and his subordinates to personnel of the Federal courts, as well as final drafts of AOUSC publications. The letters include recommendations to judges and the Judicial Conference on certain personnel actions (e.g., filling the vacancy of a bankruptcy referee).

Some of the letters and memoranda are signed copies, apparently duplicated and distributed as issuances.

Arranged chronologically by conference meeting and thereunder numerically by item on agenda, with a general folder for each meeting.

Consists of preliminary and supplementary agenda, copies of committee reports, memoranda of the Director to the Conference (including drafts and comments of AOUSC staff members), correspondence with members of the judiciary on matters of concern to the Conference, and AOUSC annual reports with related correspondence and workpapers.

[The series at one time contained the Director's minutes of meetings, but these have been permanently withdrawn from the files.]

11. LEGISLATIVE FILES, 1953-56, 6 cu. ft.

Arranged by Congress and session, and thereunder by bill number.

Consists of correspondence referring proposed legislation to the Director, his responses, and referrals to the Chief Justice for consideration by the Judicial Conference and judges having an interest in the legislation, together with copies of the bills themselves. Some files include narrative reports and statistics on judicial business to support requests for additional judgeships.

Consists of correspondence with the Chief Justice and members of the Judicial Conference and with members of the Appropriations Committees of the House and Senate, statements submitted to Congress, tables on the status of allotments and appropriations, estimates of supplemental appropriations, and printed bills.

Consists chiefly of correspondence between the Chief Judges of the Courts of Appeals and the AOUSC Director over topics to be placed on the agenda of the conferences. The files also contain offset copies of some conference committee reports and speeches.

Consists of correspondence, reports, studies, transcripts of proceedings, statements and other documentation relating to such matters as reform of the U.S. Commissioner system, establishment of a unified correctional system, removal of judges for misconduct or disability, nondiscrimination in the selection of jurors, and meetings of circuit judicial conferences. The separate enclosure files [boxes 1-6 (part) and 11 (part)] include copies of speeches, memoranda to members of the Federal judiciary, legislative proposals, and reports to committees of the Judicial Conference.

The series is useful for documenting the establishment of the Federal Judicial Center.

Much of the material relates to the activities and concerns of committees of the Judicial Conference, but the files also cover travel, seminars, conferences, proposed legislation, budgetary matters, and other program issues.

Much of this collection consists of files accumulated by Charles A. Morsky, its director, Leon Frechtel, assistant director, and Henry P. Chandler, AOUSC Director. The files include copies of the Committee's initial report to the Attorney General, printed copies of its preliminary report and tentative final report, correspondence, and considerable working papers and reference material, a portion of which relate to subsequent efforts to obtain legislation implementing the committee's recommendations. Also included in the collection are files relating to an earlier investigation of bankruptcy administration (known as the McAdoo investigation) conducted in the 1930s.
