Background Information

Created by Congress and commonly referred to as the "Naming Commission" per the William "Mac" Thornberry National Defense Authorization Act for 2021 (Public Law 116-283, January 1, 2021 370), the mission of the "Commission on the Naming of Items of the Department of Defense that Commemorate the Confederate States of America or Any Person Who Served Voluntarily with the Confederate States of America" is to provide naming, renaming, and removal recommendations to Congress for all Department of Defense items that commemorate the Confederate States of America or any person who served voluntarily with the Confederate States of America. The Naming Commission reports to the House Armed Services Committee and Senate Armed Services Committee.

The Naming Commission will deliver an in-progress briefing by October 1, 2021, and a final report by Oct. 1, 2022, to the House Armed Services Committee and Senate Armed Services Committee that includes a list of identified assets, the costs to remove or rename them, and the criteria and methods we developed to identify those assets.

The complete duties of the commission, as written in the William "Mac" Thornberry National Defense Authorization Act for 2021, are: Assess the cost of renaming or removing names, symbols, displays, monuments, or paraphernalia that commemorate the Confederate States of America or any person who served voluntarily with the Confederate States of America; Develop procedures and criteria to assess whether an existing name, symbol, monument, display, or paraphernalia commemorates the Confederate States

of America or person who served voluntarily with the Confederate States of America; Recommend procedures for renaming assets of the Department of Defense to prevent commemoration of the Confederate States of America or any person who served voluntarily with the Confederate States of America; Develop a plan to remove names, symbols, displays, monuments, or paraphernalia that commemorate the Confederate States of America or any person who served voluntarily with the Confederate States of America from assets of the Department of Defense, within the timeline established by this Act; and include in the plan procedures and criteria for collecting and incorporating local sensitivities associated with naming or renaming of assets of the Department of Defense.

Established by legislation in January 2021, the Commission is composed of eight members appointed by Republican and Democratic leaders in the Congress and by the Secretary of Defense. Sworn in on March 2 and March 17, 2021, the Commissioners bring together diverse experiences from service in the military, public office, Congress, and nonprofit organizations. By statute, the Commission will sunset on October 1, 2022.
