
This is in reply to your email of April 19, 2016, to Richard Noble of my staff providing a preliminary report on the potential loss of Federal records at Malmstrom Air Force Base (AFB), Montana.

Your email indicates that the loss of DD Forms 214 and Special Orders dating from 2004 to 2007 at Malmstrom AFB may have occurred in part during the input of hardcopy records into the Automated Records Management System administered by the Air Force Personnel Center. We understand that the Air Force Records Office is seeking additional information about the circumstances of this potential loss of records, the efforts to reconstruct records, and safeguards to prevent recurrence of such loss.

Please provide us with an updated report on this potential loss of records within 30 days of the date of this letter. The report should include the information specified in 36 CFR 1230.14. If you cannot provide this report within the 30-day period, please provide us an interim reply and indicate when the report will be submitted.
