Dear Mr. Martinez:

The National Archives and Records Administration (NARA) reviewed your letter dated 15 October 2016 reporting the unauthorized disposition of Visual Surveillance Files (VSF) (N1-318-11-1, item 6) maintained by the Bureau of Engraving and Printing (BEP), Office of Security. BEP identified that the Digital Video Recording System (DVRS) responsible for capturing VSF does not have the capability to meet the 2-year storage of records per existing retention requirements. The DVRS currently captures and maintains VSF for production area cameras for 365 days and non-production areas for 30 days, resulting in unauthorized disposition of the video files.

As the DVRS is currently in use, all VSF since the FY 2012 operation implementation have been subject to unauthorized disposition. With this in mind, the schedule change cited in your letter to mitigate future loss is critical. BEP should submit a draft schedule to NARA as soon as possible and no later than 30 calendar days from the date of this notification. Once the revised schedule is approved, NARA will consider the case closed and notify BEP via letter. Until the revised schedule is approved, BEP should take steps to prevent any further premature disposal of records.


