Dear Ms. Fawcett:

The National Archives and Records Administration (NARA)has received your letter dated June 26, 2019, notifying us of an alleged unauthorized disposition. In this letter you stated that, "the Bureau of Ocean Energy Management (BOEM) was made aware of a potential loss of records. Geologic and Geophysical (G&G) Permitting and Data Management documents from the BOEM Alaska Region were not located during a regional file room inventory project. These records would have been stored in the Bureau's regional office space in Anchorage, AK."

In accordance with 36 CFR 1230.16(b), please provide us with a response within 30 calendar days that includes a complete description of the records (including an approximation of the volume and dates of all destroyed and/or unlawfully removed records); a statement of what safeguards have been put into place (or will be put into place) to prevent any future unauthorized disposition or unlawful removal of agency records; exact details of the circumstances surrounding the unauthorized disposition of records; and an outline of any actions taken to retrieve or recreate the records.
