Introduction

On the 61 rolls of this microcopy are reproduced the court papers (1-1690), the court journal (April 29, 1946-February 11, 1948), the court exhibits (1-3915), and the opinions, judgments, and sentences (1738-1738G) of the International Military Tribunal for the Far East (IMTFE). Also reproduced are specific evidentiary documents collected by the International Prosecution Section (IPS) of General Headquarters, Supreme Commander for the Allied Powers. The rolls are number 1-62, but no Roll 29 was ever filmed. The cords are a part of National Archives Record Group 238, World War II War Crimes Records.

The records were microfilmed by the Photographic Division of IMTFE in Tokyo in 1948 with the approval of The Adjutant General's Office. Only the microcopy number, a title page for each roll, this introductory note, and a list of rolls giving for each roll its number and an indication of its contents have been added by The National Archives to the negative microfilm that was received from The Adjutant General's Office.

Any rolls of the microcopy that are not available to the public are governed by restrictions imposed by the Department of State. U.S. security-classified markings that some of the documents bore at the time of filming may now be disregarded (per DOD 5200.10). Many of the original documents bear Japanese or German security-classified markings, which are also to be disregarded.
