NONPOPULATION CENSUS SCHEDULES FOR HAWAII, 1930: AGRICULTURE

INTRODUCTION

On the 12 rolls of this microfilm publication, M1876, are reproduced general agricultural and livestock schedules reporting farm products grown or owned in Hawaii during 1929–30. These records are part of the Records of the Bureau of the Census, Record Group (RG) 29.

BACKGROUND

The Bureau of the Census was established in the Department of Commerce and Labor by order of the Secretary of that Department on July 1, 1903. Previously, temporary census offices conducted and compiled census enumerations.

The first enumeration of agricultural products was undertaken in conjunction with the taking of the seventh population census in 1840 and then repeated with each decennial enumeration thereafter. For more information, see Carroll D. Wright, *History and Growth of the United States Census* (Washington: Government Printing Office, 1900). Since 1920, agricultural censuses were taken in 1925, 1930, 1935, 1940, 1945, 1950, 1954, 1959, 1964, 1969, 1974, 1978, 1982, 1987, 1992, and 1997. In 1997 this function was transferred to the National Agricultural Statistics Services of the Department of Agriculture (USDA-NASS). Data for 1987 and 1992 were collected in 1988 and 1993, respectively, and thus are sometimes referred to as the 1988 and 1993 censuses in USDA-NASS publications.

RECORDS DESCRIPTION

These records consist of two series: (1) a "general" schedule for farms and ranges and (2) a schedule for "livestock not on farms." In Hawaii the official census day for the taking of the fifteenth decennial census ("1930 census") was April 1, 1930.

The schedules are arranged by record series, then by county, and then by enumeration district (ED) number. A sequential mechanically stamped page number is in the upper right corner of both sides of each schedule.

SERIES 1: FORM 15-71, GENERAL SCHEDULE FOR FARMS AND RANGES—HAWAII

Form 15-71, *General Schedule for Farms and Ranges—Hawaii*, measures about 10.5 by 8.5 inches, with different questions each side. One schedule was used for each farm. For the purposes of this schedule, a "farm" was defined as:

... all the land directly farmed by one person, either by his own labor alone or with the assistance of members of his household, or hired employees. The

farm . . . may produce field crops, vegetables, and fruits, as well as livestock and livestock products. No report is required of a farm of less than three acres unless there were produced on the tract in 1929 products to the value of \$100 or more, unless it required the continuous services of at least one person.

The questions asked on this schedule are shown in Appendix I. The Table of Contents indicates the page numbers corresponding to each ED.

SERIES 2: FORM 15-72, SCHEDULE FOR LIVESTOCK NOT ON FARMS-HAWAII

Form 15-72, *Schedule for Livestock not on Farms—Hawaii*, measures about 8 by 11 inches, with space for 25 keepers of livestock on each side. This schedule was used to report all livestock "kept in stables, barns, corrals, feed lots, house yards, or on nearby lots in or near cities or villages" but not those on farms.

The questions asked on this schedule are shown in Appendix II. The Table of Contents **does not** indicate the page numbers corresponding to each ED. It is possible that there are Series 2 (Form 15-72) schedules for EDs that do not have Series 1 (Form 15-71) schedules; no analysis was made during arrangement.

GENERAL COMMENTS

Some schedules for Hawaii and Honolulu counties are annotated with both the correct ED number and an incorrect ED number. Incorrect ED numbers were generally written in black ink and many, but not all, were crossed out. Correct ED numbers were generally written in red ink; sometimes these were not added.

Agricultural schedules for Kalawao County, ED 3-1, were labeled by enumerator R. L. Cooke as Maui County, Molokai Island, Molokai District, ED 3-1. They were filed (and mechanically stamped) by the Bureau of the Census at the end of the Maui schedules. Cooke's population schedules were identified by the Bureau as Kalawao County schedules in National Archives Microfilm Publication T626, *Fifteenth Census of the United States, 1930*, roll 2637.
