Dear Congressman Nadler:

This responds to your recent letter to the Attorney General regarding press accounts related to the bombing of the World Trade Center. In your letter, you referred to press reports indicating that the Federal Bureau of Investigation (FBI) may have had information prior to the bombing of the World Trade Center on February 26, 1993, as to planned terrorist activities in the New York City area. Specifically, you inquired whether these press reports were true and, if so, whether the World Trade Center bombing might have been prevented. You also asked whether we have identified any lapses in the FBI's intelligence-gathering procedures.

As I am sure you can appreciate, the sensitivity of the ongoing criminal investigation and prosecution requires us to refrain from disclosing details of the investigation that was conducted by the FBI. However, we have been advised that the FBI did not at the time of the bombing of the World Trade Center have an informant inside the terrorist group believed to be responsible for that crime.

We can also assure you that we have not identified any lapses in the investigative procedures used by the FBI in its counterterrorism program. In fact, it was the coordinated and sophisticated response of a task force of federal, state, and local agencies, led by the FBI, that resulted in the early arrests of key suspects in the World Trade Center bombing. Bureau agents are required to comply with guidelines that govern the gathering of intelligence in criminal cases. We are confident that these guidelines and procedures provide adequate safeguards to ensure the integrity of investigations aimed at terrorist activities.

I hope this information is helpful. If we can be of further assistance with regard to this or any other matter, please do not hesitate to contact this office.

Dear Attorney General Reno:

I am writing to you concerning reports today in the press which suggest that one F.B.I. informant, Emand A. Salem, had been working for the agency since at least November 1991. Today's New York Times attributes this information to an indictment, filed by the federal government, in connection with recent planned terrorist actions in my congressional district.

I am sure that you can appreciate the significance of such a revelation. If the Bureau had an informant inside the terrorist organization believed to have planned and, apparently, executed acts of terrorism against American citizens in the heart of New York City, it would suggest a significant, and possibly fatal, lapse by the F.B.I.

I would appreciate being informed whether there is any truth to these press reports, and if so, whether this informant provided any advance information which could have helped prevent the bombing of the World Trade Center, located in my district. I would also appreciate being informed what lapses you have identified in the Bureau's anti-terrorism intelligence gathering procedures as a result of this incident, and what steps you intend to take to ensure that lapses of the type described in these press accounts do not occur in the future.


As Attorney General, you have demonstrated an outstanding commitment to preventing domestic terrorism as well as a staunch determination to apprehend the perpetrators of these despicable acts and bring them to justice. Certainly the speed with which the Department moved against the suspects in the World Trade Center bombing stands as a comfort for all Americans and a warning to those who would threaten violence against our citizens here or abroad.

SUBJECT: World Trade Center bombing

You asked about the allegation that the federal government dropped the ball in failing to investigate information we had that might have forewarned us about the bombing of the World Trade Center.

In brief, here's the story.

El Sayyid Nosair was charged with the November 6, 1990 murder of Rabbi Meir Kahane in New York. Nosair, who was wounded in the attack, lived in Cliffside Park, New Jersey. FBI agents from Newark and New York City police searched his residence and seized "voluminous" writings and tape recordings.

These included a document that described a need to "break and crush the will and design of the enemy of God" by "crushing and exploding the structures upon which their civilization stands. By this I mean their tourist sites, their tall buildings, their statues, and the edifices where their leaders meet."

The FBI says the documents were scanned for pertinent terrorist material by translators, but much of the Arabic material was not translated verbatim at the time. The reference to "tall buildings" was not perceived as an indication of an impending attack against the World Trade Center. Nor was any special significance attached to tourist type photographs of various historical and municipal scenes, including some with the World Trade Center in the background.

Nosair was actively involved with several of the individuals involved in the World Trade Center bombing. The failure of the FBI to fully translate the material found in Nosair's residence and see in it a threat to the World Trade Center has been the centerpiece of several journalistic post-mortems.

An FBI report is attached.

AT 9:06 P.M. ON NOVEMBER 6, 1990, JEWISH DEFENSE LEAGUE (JDL) FOUNDER MEIR KAHANE WAS SHOT AND KILLED AT THE HALLORAN HOUSE HOTEL IN NEW YORK CITY. KAHANE WAS SPEAKING AT A FUND RAISING EVENT WHEN EL SAYYID NOSAIR APPROACHED KAHANE AND FIRED A RUGER .357 MAGNUM AT KAHANE STRIKING HIM IN THE NECK. NOSAIR ALSO SHOT A SPECTATOR, IRVING FRANKLIN, IN THE THIGH. OUTSIDE THE HOTEL, NOSAIR ATTEMPTED TO COMMANDEER A TAXI AT GUNPOINT. POSTAL POLICE OFFICER CARLOS ACOSTA EXCHANGED GUNFIRE WITH NOSAIR AND EACH WERE WOUNDED IN THE EXCHANGE.

SUBSEQUENT INVESTIGATION REVEALED THAT NOSAIR WAS USING THE ADDRESS OF HIS COUSIN, IBRAHIM EL GABROWNY, 57 PROSPECT PARK, SOUTHWEST, APARTMENT 4C, BROOKLYN, NEW YORK. EL GABROWNY AND ANOTHER INDIVIDUAL NAME KHALED IBRAHIM WERE INTERVIEWED ON NOVEMBER 7, 1990. THIS INTERVIEW QUICKLY DETERMINED THAT EL GABROWNY AND IBRAHIM WERE INVOLVED WITH THE ALKIFAH REFUGEE CENTER (LOCATED AT THE FARUQ MOSQUE) WHICH WAS UNDER FBI INVESTIGATION FOR POSSIBLE NEUTRALITY ACT VIOLATIONS IN 1988 AND 1989. THIS ENTITY WAS SUPPLYING FUNDS AND TRAINED MEN TO FIGHT IN AFGHANISTAN. NEW YORK BELIEVES THAT ATTEMPTS TO SUPPLY LARGE AMOUNTS OF 7.62MM AMMUNITION AND WEAPONS TO AFGHANISTAN WERE ALSO BEING CONDUCTED.

IT WAS DETERMINED THAT A RADICAL CLERIC, IDENTIFIED AS SHEIK OMAR ABDEL RAHMAN, WAS PREACHING AT THE MOSQUE THAT NOSAIR FREQUENTED. IT WAS LEARNED THAT NOSAIR WAS A FOLLOWER OF RAHMAN'S IDEOLOGY AND DRIVING FORCE IN THE TRAINING OF MEN TO BE SENT TO AFGHANISTAN. FURTHER CHECKS INTO NOSAIR'S ASSOCIATES INDICATED THAT HE HAD RELATIONSHIPS WITH OR PARTICIPATED IN FIREARMS TRAINING WITH MAHMOUD ABDOHALIMA AND NIDAL AYYAD, WHO WERE BOTH LATER CONVICTED OF BOMBING THE WORLD TRADE CENTER.

NOSAIR, BY HIS CONVICTION, BECAME A "HERO" TO MANY FOLLOWERS OF RAHMAN'S VIOLENCE PRONE CONCEPT OF JIHAD IN THE UNITED STATES AND OVERSEAS. NOSAIR CONSTANTLY ENCOURAGED OTHERS TO CONTINUE ACTS OF VIOLENCE IN THE UNITED STATES. HE WAS VISITED IN PRISON BY MAHMOUD ABDOHALIMA, NIDAL AYYAD AND MOHAMMED SALAMEH, WHO WAS ALSO CONVICTED OF THE WORLD TRADE CENTER BOMBING.

NOSAIR EVIDENCE:

ON NOVEMBER 6, 1990, THE FBI NEWARK OFFICE AND THE NEW YORK CITY POLICE DEPARTMENT CONDUCTED A SEARCH OF NOSAIR'S RESIDENCE AT 577 OLYMPIA AVENUE, CLIFFSIDE PARK, NEW JERSEY.

THIS EVIDENCE, WHICH WAS VOLUMINOUS, WAS COLLECTED AND TURNED OVER TO NEW YORK CITY DISTRICT ATTORNEY'S OFFICE. THE FBI DID, HOWEVER, REVIEW THE EVIDENCE FOR ANYTHING THAT COULD BE RELATED TO AN INTERNATIONAL TERRORIST CONSPIRACY. AN ASSESSMENT OF THE EVIDENCE AT THE TIME SHOWED NOSAIR AS A PERSON DEDICATED TO THE CONCEPT OF A VIOLENT TYPE JIHAD AND THAT HE HAD AN INTEREST IN FIREARMS AND EXPLOSIVES. MUCH OF THE ARABIC WRITING WAS NOT TRANSLATED VERBATIM AT THE TIME, BUT WAS SCANNED FOR PERTINENT TERRORIST MATERIAL BY TRANSLATORS. AMONG THE LATER TRANSLATED MATERIAL WAS A DOCUMENT THAT TALKED ABOUT "BOMBING TALL BUILDINGS". THIS DOCUMENT MERELY REINFORCED WHAT WAS ALREADY KNOWN AND BEING PURSUED, IN THAT NOSAIR WAS PART OF A GROUP, OR MOVEMENT, THAT ADVOCATED VIOLENCE FOR THE FURTHERANCE OF RADICAL ISLAMIC CONCEPTS. THIS GROUP WAS ALREADY IDENTIFIED AS AL-GAMA-AL-ISLAMIYYA UNDER THE LEADERSHIP OF SHEIK OMAR ABDEL RAHMAN. THE TERM "BOMBING TALL BUILDINGS" APPEARS IN THE FOLLOWING CONTEXT: "...IT IS NECESSARY TO BREAK AND CRUSH THE WILL AND DESIGN OF THE ENEMY OF GOD BEFORE ANNOUNCING THE ESTABLISHMENT OF 'ABRAHAM'S STATE.' THIS MUST BE CARRIED OUT BY CRUSHING OR EXPLODING THE STRUCTURES UPON WHICH THEIR CIVILIZATION STANDS.

THE NEW YORK OFFICE HAD ALREADY INITIATED A "265 CLASSIFICATION - ACT OF TERRORISM-HOMICIDE" INVESTIGATION. WHILE THE EVIDENCE SEIZED WAS IN THE HANDS OF THE NEW YORK DISTRICT ATTORNEY, THE FBI AGGRESSIVELY FOLLOWED UP ON THE INVOLVEMENT OF NOSAIR AND HIS RELATIONSHIP TO SHEIK RAHMAN, AFGHANISTAN, FIREARMS TRAINING AND POSSIBLE CO-CONSPIRATORS TO THE KAHANE MURDER. THE EVIDENCE WAS AGAIN REVIEWED BY SPECIAL AGENTS AT NEW YORK, BUT REMAINED IN THE CUSTODY OF THE NEW YORK DISTRICT ATTORNEY. THE CIVIL RIGHTS CASE WAS BEING PURSUED UP UNTIL THE FEBRUARY 26, 1993 BOMBING OF THE WORLD TRADE CENTER. SHORTLY THEREAFTER, AN FBI NEW YORK CONFIDENTIAL SOURCE RE-ENTERED CIRCLES OF PEOPLE IN THE AL-GAMA-AL-ISLAMIYYA AND PENETRATED A CELL THAT WAS PLANNING TO ATTACK VARIOUS TARGETS IN THE NEW YORK AREA, INCLUDING THE FEDERAL BUILDING, UNITED NATIONS, LINCOLN AND HOLLAND TUNNELS. THIS LED TO THE ARREST OF 14 INDIVIDUALS, INCLUDING NOSAIR AND SHEIK RAHMAN. IN ORDER TO PURSUE A CASE OF SEDITIOUS CONSPIRACY AGAINST NOSAIR, THE EVIDENCE WAS TURNED OVER BY THE NEW YORK DISTRICT ATTORNEY IN AUGUST, 1993, AND REVIEWED BY FBI NEW YORK. MANY OF THE "RELIGIOUS" WRITINGS, TAPES AND
