Passport Facilities for Nancy Mangabeira UNGER

I refer to your memorandum of January 20, 1971 in this matter.

Of course, we will follow your instruction. However, it would seem that a minimum of prudence and responsibility for security and political interests of the United States would require some consideration of the following information and facts:

1. Subject is a dual national, possessing both Brazilian and United States nationalities.
2. She has been living in Brazil for most of her life.
3. She has not deemed her claim to United States citizenship important enough to maintain valid documentation as such.
4. She has been engaged in violent anti-government activities in Brazil for some time.
5. She was engaged in a public "shoot out" with Brazilian security police.
6. Embassy referred to her case as a "political tinderbox".
7. Mother admitted to consul that subject is "deeply involved in subversion and plan to kidnap diplomat".
8. Mother admits subject went "underground" in January 1970.
9. Brazilian government publicly announced subject had intended to kidnap American consul general. Headlines were in local paper in Recife.
10. Subject previously arrested for having melotov cocktails in her car.

11. Subject identified as being involved in bank robbery which netted \$800,000, and in the murder of one officer and wounding two others.
12. Subject was one of radical group released by Brazilian authorities in exchange for kidnapped Swiss ambassador.

You may wish to review the provisions of Section 51.70 (b)(4) CFR in the light of the foregoing. This section is quoted below for your convenient reference:

"(4) The Secretary determines that the national's activities abroad are causing or likely to cause serious damage to the national security or the foreign policy of the United States."

The Passport Office must note its vigorous objection to the action proposed in SCA's memorandum of January 20, 1971, which would assist such a person to engage as an American citizen in further actions which are an outrageous affront to civilized society.
