Arranged according to a numerical filing scheme; for example, File 45E 337 pertains to the political activity of Deputy Marshals in the Eastern District of Texas.

Arranged by Judicial District.

- 13. Entry A1 61, Card Index to Records Relating to Administration of Judicial Districts, 1884-1912 Includes the names of Marshals and the relevant Department of Justice file numbers. Arranged judicial districts and thereunder by office and date of appointment.
- 14. Entry A1 70, Card Index to the Files of U.S. Attorneys and Marshals, 1900-1912 Gives names of Marshals, Department of Justice file numbers, and judicial districts in which they served. Some Deputy Marshals listed.
- 15. Entry A1 346, Card Index to U.S. Marshals, 1789 1960 Includes the name of the Marshal, the date of his nomination, the date of his commission, the judicial district in which he served, the name of his predecessor, and the source of this information.

 This series contains letters reporting on the volume of work performed in the various judicial districts, requesting blank forms for use in reporting, and explaining delays in sending reports. Arranged by state, thereunder by judicial district, and thereunder chronologically.
- 3. Entry PI-171 153, Reports of U.S. Marshals, 1821-1885, includes "Marshals Returns."

 Reports submitted to the Solicitor, informing them that proceedings had been initiated in which the U.S. was a party or had an interest. The reports are arranged by judicial district and thereunder chronologically.

National Archives at Washington, DC

1. Entry A1 316, Emolument Returns for District Attorneys, Clerks of Courts, and Marshals, July 1842- March 1907.

Arranged alphabetically by name of state and thereunder by type of official. Returns consist of abstracts approved by the Attorney General showing source and amount of funds received by the official, services they performed, approved mileage charges, and miscellaneous expenses for which he was entitled to compensation. The abstracts for Marshals also show the names of Deputy Marshals and the amounts to which they were entitled as fees, salaries, and expenses.

Deputy Marshals

In order to undertake a search for information about individual Deputy Marshals, we need to know the individual's full name, the time period of their service, and the judicial district or at least the geographical area where they worked. Depending on the time period of service, information about individual Deputy Marshals can sometimes be found in the following series of records:

1789-1841

Information about individual Deputy Marshals during this time period is extremely limited. The names of Deputy Marshals are sometimes mentioned in Letters Received, 1809-1870 of the records of the Office of the Attorney General, and Letters Received Related to Judiciary Accounts, 1849-1889.

1842-1896

An initial search would start with the emolument returns of U.S. Marshals among the Records of the First Auditor's Office in RG 217. RG 217 is at the National Archives at Washington, DC.

For the time period 1871-1884, researchers should consult the Source Chronological Files under the state or judicial district. From 1884 onward, researchers should consult the Year Files, 1884-1903.

1897-1937

Returns of Fees and Allowances of U.S. Marshals and Deputy Marshals, 1896-1912, give the names of Deputy Marshals and the expenses incurred by each.
