
REFERENCE : Concludes that Oswald signed his Cuban visa application

1. In response to reference request the signature "Lee H. Oswald" on a reduced size photograph of a Cuban Visa Application was compared with numerous writings of Oswald in Xerox copy of Vol. 3 of Exhibits in "Investigation of Assassination of President John F. Kennedy, November 22, 1963" to determine if the questioned signature on the Cuban Visa Application was written by Oswald.

2. It is our conclusion that Lee H. Oswald is the author of the signature in that name on the Cuban document.
