re: report on PRI activities

I. ACTIONS TAKEN: (1) LIMIX-1 [redacted]

[redacted] Copies are included as
to this report. This [redacted] contains good photographic
coverage of the national convention of the PRI; an article on page
3 which is based on previous speeches by the new President of the
PRI, Alfonso MARTINEZ Domínguez; a series of interviews with po-
litical and intellectual figures regarding MARTINEZ Domínguez on
page 4; an article boosting the future leader of the federal
workers union, Prof. Edgar ROBLEDO Santiago, on page 13; and, a "plug"
for the Olympics on the back page, in addition to other serious and
light features of general interest. (2) LIMIX-1 [redacted]

[redacted] (see Attachment B) which
contains the inaugural speech of the new President of the PRI and
the new PRI "official mayor", Fluvio VISTA Altamirano, and which
is included as an insert with the Attachment A newspaper. (3) (LI-01-
MIX-1) provided the Station with information from very reliable
sources on the reasons for the dismissal of Lic. Francisco GALINDO
Ochoa from his post in the Presidency and on what the government
expects of MARTINEZ Domínguez in the PRI. (4) [redacted] LI-
MIX-1) continued a close relationship with [redacted]

[redacted] who is supposed to be a good friend of the new President of
the PRI. (5) The representative of the Municipal Government of
Mexico City [redacted] provided

[redacted] group with a second office, also located in a
building owned by the Municipality. (6) The [redacted] group continued,
now with official support, to organize athletic events, show motion
pictures provided by QKFLOWAGE and the West German embassy and
activities related to organization of PRI youth activities in this
zone of Mexico City (Atzacozalco). (7) The LIMIX-1 [redacted] headed
by [redacted] suffered a "temporary loss" of its TV programs and

[redacted] was busy trying to find governmental contacts with suffi-
cient power [redacted]

(LIMIX-1) believes the loss was caused by the dismissal of GALINDO
Ochoa from the Presidency. (GALINDO) had given [redacted] un-official
support in his relationship with the TV Station management. It
is believed that [redacted] time can be recovered; however, [redacted]
is also investigating the possibility of obtaining time on a
commercial TV channel and a radio station. (8) [redacted] and (LIMIX-1)
continued cultivation of Lic. [redacted] who is employed
as [redacted] to Lic. [redacted] the Private
Secretary of the President of Mexico. (LIMIX-1) also had several

meetings with the Private Secretary of [redacted] (Lic. [redacted])
 [redacted] (9) (LIMIX-1) prepared, published, and distributed [redacted] which
 included an interview with the new President of the Federación
 Nacional de Estudiantes Técnicos (FNET), José CEBREROS, on page
 6, several articles provided by QKFLOWAGE and the West German
 embassy as well as other material of interest to IPN students.
 The CEBREROS interview was an "exclusive". (10) (LIMIX-1) was able
 to obtain one of the 2,000 "tickets" available for the national
 convention of the PRI, and attended both day's meetings. (11)
 (LIMIX-1) provided the Station with a report on the FNET Congress
 and his participation therein. As a result, a close friend of
 (LIMIX-1) was named [redacted] the President of the FNET, and (LIMIX-1) was named one of the
 [redacted] the FNET President. (12) (LIMIX-1) continued contact
 with a variety of political personalities with the objective of
 being able to penetrate the [redacted]

II. ACTIONS PENDING: The major pending action is the [redacted] and/or friendships within the [redacted] once the situ-
 ation in [redacted] has solidified to some degree. For ex-
 ample, Lic. [redacted] sits in a sort of "limbo" at this date,
 neither out of his job, nor confirmed in a job. However, it would
 appear that the (LIMIX) mechanism has at least five channels into
 the new [redacted] which are being developed
 for appropriate utilization. A separate report will be prepared
 on these channels into the [redacted] Other channels exist to
 provide contacts within the [redacted] for Mexico
 City, but nothing can be done until current officers are retired
 and the new men appointed.

III. INDICATIONS OF EFFECTIVENESS: As reported in paragraph I,
 #3, 5, 10 and 11.

IV. ADMINISTRATIVE NOTES: Nothing new to report.

V. SECURITY SITUATION: No security problems were encountered.

VI. AGENT MEETINGS: Meetings between FREAPANE and (LIMIX-1) were
 held on a weekly basis in a restaurant.

VII. REMARKS: While [redacted] operations are no longer the priority
 of operations of this project, FREAPANE continues to encourage (LIMIX-1)
 contact with the [redacted] because of the continuing,
 and even increasing political problems caused by [redacted] thus providing WOFIRM with a continuing possibility for
 intelligence gathering and political action in this field.
