2. IDEN 2 REF A NOT ADVISED BY US INSTRUCT IDEN 1 REF A. SINCE *A*

ASSUMES IDEN 2 OUR COLLEAGUE, IMPLYING WE ABLE CHECK HIM OUT RE HIS INSTRUCTIONS TO IDEN 1. FEEL CERTAIN *A* NOT FABRICATING.

3. IDEN 2'S MOTIVES INSTRUCT IDEN 1 SHUN *A* APPEAR BE DESIGNED PROTECT *A* FROM MARITAL AND OTHER DIFFICULTIES INHERENT WITH IDEN 1'S PRESENCE MOSCOW, DEPENDING ON INTIMACY *A's* RELATIONSHIP WITH IDEN

1 DURING HIS SOJOURN BRUS. FURTHERMORE, SUSPECTING OUR INTEREST IN *A* IDEN 2 MIGHT HAVE TAKEN INITIATIVE PROTECT THIS INTEREST AS FAVOR TO US. IN EITHER CASE WE CANNOT QUERY IDEN 2.

6. SINCE IDEN 1'S ACQUISITION CURRENT JOB PROBABLY BASED HER CONNECTIONS.
