

A. MECHANICS OF LATENT POUCH TO PERUVIAN: LETTERS AND PACKAGES WRAPPED AND SEALED CLASSIC MANNER, ENCLOSED IN CANVAS POUCHES WITH 30 X 40 CENTIMETER OPENING. POSSIBLE, HOWEVER, SEND LARGER PARCELS BY AIRMAIL. IT IS VIRTUALLY UNLIKELY THAT ITEM BEING ADDRESSED TO PRIVATE INDIVIDUALS PERUVIAN.

B. LIMITATIONS OF USE: NO LIQUIDS OR EXPLOSIVES.

C. FREQUENCY: IN EFFECT THERE ARE TWO POUCHES MONTHLY. FOR EXAMPLE ON 13 DEC, CIA OFFICER STATIONED HERE WILL TAKE POUCH PERUVIAN, RETURN WITH POUCH FROM EMBASSY PERUVIAN. APPROXIMATELY TWO WEEKS LATER, OFFICER FROM EMBASSY IN PERUVIAN WILL COME HERE AND REPEAT PROCESS. NO PLANNED CARRIER ROSTER.
