1. BACKGROUND. PRESS, WIRE SERVICES TODAY REPORT ARREST IN LEOPOLVILLE, CONGO, TWO SOV DIPLOMATS, BORIS VORONIN, COUNSELOR SOV EMB, YURI NYAKOTNYKH, PRESS ATTACHE, UPON RETURN FROM BRAZZAVILLE (CAPITAL FORMER FRENCH CONGO), WHEN INCRIMINATING DOCUMENTS, PROVING SOV SUPPORT FOR CHRISTOPHE GBENYE, FOLLOWER OF LATE LUMUMBA, NOW TRYING FORM CONGO EXILE GOVT IN BRAZZAVILLE, FOUND IN THEIR POSSESSION. SOV GOVT NEWSPAPER IZVESTIA, MOSCOW, 20 NOV, DENOUNCED "SHAMEFUL PROVOCATION" AND "BANDIT METHODS". CONGO GOVT EXPECTED TO SUSPEND OR BREAK DIPL RELATIONS WITH SOVS, CZECHS.

2. GUIDANCE. MAXIMUM PUBLICITY ABOVE EVENT, PLUS FURTHER DEVELOPMENTS CASE. URGENTLY DESIRED. DISREGARD HOLD PARA ONE REF., FOR ALL FACTS ALREADY IN PUBLIC DOMAIN. ALL TREATMENT SHOULD DISPLAY ALLEGED MISHANDLING OR BEATING SOV OFFICIALS AND ERGOT DRAMATIC EMPLOYERIES LIKE SULPHUR ACID PLOT
