1. SUBJ REF BORN 4 OCTOBER 1931 IN CHICAGO, WAS ISSUED PASSPORT 2456342 ON 11 OCTOBER 60 FOR TWO MONTHS VISIT CENTRAL AND SOUTH AMERICA AND CARIBBEAN AREAS FOR PLEASURE. EXAMINATION OF PASSPORT APPLICATION INDICATED THAT SUBJ STARTED TO PUT SEPARATED UNDER MARRIAGE STATUS THEN CROSSED IT OUT AND INDICATED THAT MARRIAGE NOT TERMINATED. AS OF JUNE 61 SUBJ WAS WORKING UNDER LICENSE OF THE ACCURATE DETECTIVE LABORATORIES.
